

## BE Energy 'Budget Bonus 28%' Discount Plus Tariff

### Scope of Agreement

1. These terms apply to the BE Energy 'Budget Bonus 28%' Discount Plus Tariff, including Nightsaver, ("the *Tariff*"). This tariff allows customers to avail of a 12-month fixed term contract. The eligibility criteria to avail of the Tariff are as follows:
  - You must be a domestic electricity customer in the Republic of Ireland;
  - You must hold an electricity account with BE Energy to avail of this price plan;
  - You must pay monthly by Direct Debit;
  - You must provide an email and receive online bills.
2. These terms are in addition to the General Terms and Conditions for the Supply of Electricity by BE Energy Ltd to Domestic Premises in Republic of Ireland' ("*BE Energy's General Terms and Conditions*") (as may be amended from time to time and which can be found on our website at [www.beenergy.ie](http://www.beenergy.ie) or obtained by calling us on Freephone 1800 817 383) and the BE Energy Ltd Customer Agreement Form ("*CAF*").
3. These terms and conditions, together with the BE Energy General Terms and Conditions and the CAF are referred to as the "*Agreement*".
4. In the event of any conflict between these terms, the BE Energy General Terms and Conditions and the CAF, these terms will apply.

### Tariff Discount

5. Your discount ("*Tariff Discount*") as set out in the table below is against the BE Energy Standard tariff rate ("*BE Energy Standard*"). BE Energy Standard rates may be amended from time to time during the Term, but this will not affect your Tariff Discount.

(BE Energy 'Budget Bonus 28%' Discount Plus tariff rate presents a 28% discount from BE Energy's Standard Tariff unit rate. The discount is not applied to the Standing Charge)

6. Details of the BE Energy 'Budget Bonus 28%' Discount Plus Tariff unit rate and other charges can be viewed on our Tariff Information Page available on our website at [www.beenergy.ie/tariffinformation](http://www.beenergy.ie/tariffinformation)
7. Your discount will be applied from the date that BE Energy Ltd is registered as your new supplier, or from the date we have agreed, and will continue for 12 months (the "*Discount Term*").
8. The method of payment for BE Energy 'Budget Bonus 28%' Discount Plus Tariff shall be Monthly Direct Debit. If you do not pay by direct debit, or if you subsequently cancel your direct debit, a €300 deposit will be applied to your account.

9. The method of billing for BE Energy 'Budget Bonus 28%' Discount Plus Tariff shall be online billing. If you do not avail of online billing BE Energy reserve the right to apply an annual charge for paper billing. This will not be more than €12 per year.
10. After expiration of the Discount Term or if you leave the Discount, you BE Energy account will be switched to the BE Energy 'Standard Tariff' applicable at that time.
11. If you move house during the Discount Term, you may continue to avail of this Discount for the remainder of the Discount Term for electricity supply at your new address, providing you continue to meet the eligibility criteria as set out in paragraph 1 above.
12. This discount may not be used in conjunction with any other BE Energy Ltd electricity offer, discount or tariff, unless otherwise specified by BE Energy Ltd during your registration and/or on your CAF.

### Ending This Agreement

14. If, at any time, you do not meet the eligibility criteria, as set out in paragraph 1 above, BE Energy Ltd reserve the right to end this agreement and transfer you to the most appropriate tariff at that time and you will be notified of any change using your chosen method of communication.
15. You may cancel the Tariff during the 10 working days from when the Agreement is first made ("*Cooling Off Period*") by writing to BE Energy, PO Box 42, Lifford, Donegal, by email to [info@beenergy.ie](mailto:info@beenergy.ie) or by calling us on Freephone 1800 817 383. There is no penalty for cancelling your switch during the 'Cooling Off Period'. If you leave the Tariff after the "Cooling Off Period" or the Agreement is ended by you at any time before the end of the 12 Month fixed term, a termination charge of €100 (inc VAT) may be applied to your account.

### Variations to this Agreement

16. BE Energy Ltd reserves the right to amend the electricity unit rates or charges that apply to the Tariff at any time during the Term if there is a cost imposed upon BE Energy Ltd by a governmental or statutory body (including a change in VAT) or as otherwise provided for in the BE Energy General Terms & Conditions. If your tariff rate changes during the term we will notify you 21 calendar days in advance using your chosen method of communication.
17. BE Energy Ltd reserves the right to withdraw the Tariff without notice at any time prior to the start of the Term.

### At the end of the Agreement

18. We will give you notice, between 30 and 60 calendar days (the 30 Days Notice) in advance of the Term of the Agreement coming to an end, using your chosen method of communication. We will notify you of the BE Energy 'Standard Tariff' applicable at that time.
